PURPOSE

OBJECTIVES

- To contribute to the effective functioning of the IEC at the VSPM's College of Physiotherapy so that a quality and consistent ethical review mechanism for health and biomedical research is put in place to all proposals dealt by the committee.
- To promote fair policies and procedures that maximize the likelihood of achieving good, patient centered outcomes.
- To review and approve all types of research proposals involving human participants with a view to safeguard the dignity, rights, safety and well being of actual or potential research participants
- Consultation for ethics in clinical research

FUNCTIONS

The IEC has the following functions

1. To maintain a consistent scientific and ethical framework for patient care and research, and for integrating ethical values into practice, policy relationships, and organizational activities.
2. To review and approve proposals for clinical, basic or translational research for scientific and ethical content.
3. To resolve ethical dilemmas and improve ethical standards
4. To work as a forum to advise the administration in case of any ethical issues that may arise from patients, families or the public.
5. To support researcher in ethical issues taking care of principles of ethics.
