Dr. Y Praveen presented the progress of respective criteria books and also presented the requirements that are to be met by the management for NAAC purpose.

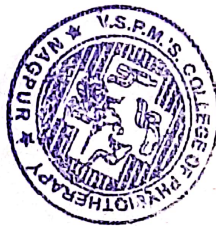

Salient Points discussed and highlighted at the meeting

NAAC Review meeting was held at the Dream Hall at 11 am in the presence of Secretary Sir Mr. Sudhir Deshmukh to review the Criterion wise work done and to assess the Gap Analysis. The Criterion heads presented their respective criterias and presented their completed work in PPT format and the difficulties they are facing in certain areas. Dr. Y Praveen presented the gap analysis of all the criterias.

Criteria 1:

Mechanism to obtain structured feedback on curricula/syllabi from various stakeholders was discussed and the lacunae were pointed. It was pointed out that a strong feedback system needs to be established so that the feedbacks are collected from time to time and necessary analysis and necessary documentation to be maintained. Stakeholder feedback report which is must was pointed out by Principal Dr. Maneesha Deshpande, and encouraged the staff to expedite the work.

Criteria 2:

The 2.4.4 criteria which demands the percentage of teachers trained for development and delivery of e-content / e-courses during the last 5 years was the major loophole. The Honorable secretary suggested the criteria head Dr. Rashmi Ronghe to meet Dr. Moana from NKP and obtain her inputs on the same. It was proposed to work on this the domain more strongly and the teachers needs to be given that platform to be trained in various e-courses/e-content so that they can delivery the e content for the benefit of the students and the institute.

Criteria 3:

Under this criteria 3.1.3, it was pointed out that there is a deficiency in the number of research projects/clinical trials funded by government, industries and non-governmental agencies during the last five years. It was suggested by Dr. Y Praveen sir that the staff should be encouraged to initiate projects and seek MUHS funding. Moreover he suggested that all the staff should get enrolled with the Swayam online portal and Shodhganga which reflects the research work of various institute at a central level.

Another gap recognized was in 3.5.1 which requires Average number of Collaborative activities for research, faculty exchange, student exchange/ Industry-internship etc. per year for the last five years. Dr. Y Praveen pointed out that though VSPM's College of Physiotherapy gets externs every year from MP and Chhattisgarh states, however student and faculty exchange SOP needs to be formulated and implemented in the next cycle.

Criteria 4:

A discussion was initiated on 4.4.1 and 4.4.2 which points out the Percentage of classrooms, seminar halls and demonstration rooms linked with internet /Wi-Fi-enabled ICT facilities (data for the preceding academic year) and Institution's IT facilities and computer availability for

students including Wi-Fi. It was put forth that though the ICT facilities are made available in the classrooms the availability of wi-fi passwords to all the students still needs to be worked out.

Point number 4.5.1 which deals with Average expenditure incurred on maintenance of physical facilities and academic support facilities excluding salary component as a percentage during the last five years needs to be prepared and was lacking. Dr. Maneesha Deshpande requested the criteria head Dr. Pushpa Dhote mam to take help from the NKP staff members and to expedite the work.

Criteria 5:

Criteria 5.1.3 which requires the Average percentage of students provided training and guidance for competitive examinations and career counseling offered by the Institution during the last five years was lacking. So, it was suggested to undertake one career counseling session in short notice so that the lacuna can be fulfilled. A career guidance firm Krishna Consultancy was promptly contacted and a session was arranged for the students on 31st December 2021 at 1.30 pm at Dream hall.

Issues were put forth regarding the registration of the Alumni Association and Dr. Abhijeet Deshmukh briefed the gathering about the progress of the same.

Criteria 5.4.2 requires the areas of contribution by the Alumni Association. Donation in finance or kind by the present Alumni who are currently serving the institute as Faculty members was put forth and a wheelchair donation was agreed upon by Dr. Pooja Akhtar, Dr. Abhijeet Deshmukh, Dr. Kartik Shah, Dr. Priyanka Deshmukh and Dr. Shyam Chaudhari which was successfully implemented.

Criteria 6:

Criteria 6.5.1 which requires the Institution to have streamlined Internal Quality Assurance Mechanism was put forth. The need to discuss the documentation of a functional IQAC cell was discussed and all the necessary mechanisms needs to be revived were highlighted. The list of PDP, FDP and quality improvement programs till date was to be submitted to the IQAC committee. The success of the program 'Curriculum implementation and support system' conducted by Dr. Madhur Gupta on 4th Oct 2021 was shared by the members.

Criteria 7:

The gap in 7.1.2 which requires the Measures initiated by the Institution for the promotion of gender equity during the last five years were discussed. Dr. Kiran Janbandhu presented her views regarding the progress of the same and the gap which needs to be addressed.

The meeting ended up with encouraging all the staff members of VSPMCOP by honorable Mr. Sudhir Deshmukh Sir to set up goals and deadlines and update the management from time to time about the progress of NAAC.

Meeting ended with thanks to Honorable Secretary Sir for sparing his valuable time and giving his inputs .

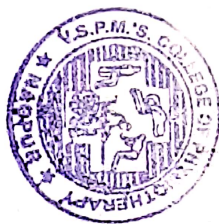


